



INVITATION TO BID

ASPHALT PATHWAYS REPAIRS LISLE PARK DISTRICT

Notice is hereby given to potential Bidders that the Lisle Park District (the "District," "Park District," or "Owner") will receive sealed bids for the above referenced Project until June 10th, 2026, at 10 am at the Lisle Park District Recreation Center, 1925 Ohio St., Lisle, IL 60451 at which time the bid proposals will be publicly opened and read aloud.

Each bid must be placed in a sealed, opaque envelope and shall be clearly marked "Sealed Bid – Asphalt Pathway Repairs" and addressed and delivered to the Lisle Park District, Attention: Aaron Cerutti, 1925 Ohio St. Lisle, IL 60532.

Bid documents are available electronically at lisleparkdistrict.org or by contacting Aaron Cerutti, Superintendent of Parks and Facilities, at 630-353-4381 between 7 am and 2:30 pm Monday through Friday. Contractors are responsible for the completeness of the documents they receive.

A mandatory pre-bid meeting will be held at Lisle Park District Recreation Center, 1925 Ohio St., Lisle, Illinois on June 4th, 2026, at 10 am. This meeting will be used to review the Specifications and give any Bidders the opportunity to discuss any questions or concerns with the Owner. No bids will be accepted by persons not having been in attendance.

The District reserves the right to waive all technicalities, to accept or reject any or all bids, or to accept only portions of a bid and reject the remainder without disclosure for any reason. Failure to make such a disclosure will not result in accrual of any right, claim or cause of action by any Bidder against the District. Owner will award the Contract to the lowest most responsible and responsive Bidder, as determined by Owner. In considering the Bidder's responsibility, the Owner may evaluate, among other factors, the ability of the Bidder to provide experienced labor sufficient in numbers to timely and properly complete the Work, the financial capability of the Bidder, and the performance of the Bidder on other projects.

Bids shall not include federal excise tax or state sales tax for materials to be incorporated in, or totally consumed in the prosecution of the Work. A tax exemption certificate will be furnished by the Park District at the request of the Bidder. The Park District's tax exemption number shall only be used by the successful Bidder for the Work of this Project only.

After the bid opening, no bid may be withdrawn or canceled for a period of (60) calendar days.

The Work of this Project is subject to the Illinois *Prevailing Wage Act*, 820 ILCS 130/0.01 *et seq.* A prevailing wage determination has been made by the Illinois Department of Labor for public works projects in DuPage County. The Contract entered into for the Work will be drawn in compliance with said law and proposals should be prepared accordingly and provide for payment of all laborers, workmen, and mechanics needed to perform the Work at no less than the prevailing rate of wages (including the prevailing rate for legal holiday and overtime work as applicable) for each craft, type of worker, or mechanic.

All bids must be accompanied by cashier's check, certified check, or bid bond payable to the order of the Lisle Park District for ten percent (10%) of the amount of the bid as provided in the Instructions to Bidders. No proposals or bids will be considered unless accompanied by such bond or check.

The Contractor(s) selected will also be required to comply with all applicable federal, state and local laws, rules, regulations and executive orders, including but not limited to those pertaining to equal employment opportunity.

The Lisle Park District encourages small and minority businesses and women's business firms to submit bids on the approved project and successful contract bidders to utilize small and minority businesses and women's businesses as sub-contractors for supplies, equipment, services, and construction.
