IX. NEW BUSINESS

A. Amendment to the Intergovernmental Agreement Lisle Community School District 202 and Lisle Park District for Shared Use of Grounds and Facilities-Discussion.

Director Garvy stated in the Board Packet is a draft of the IGA amendment which assures the school district that the park district will make Community Park field #7 available for their priority use. He asked that if the board has any questions or concerns that they let him know as it is staff's intent to have these two documents before the board for final action at the Regular Meeting of September 17. Commissioner Altpeter stated she had had a conversation with Director Garvy earlier in the week and had asked that the temporary construction easement document contain more specific language regarding the field's improvements and the school district's need to follow all local rules, regulations and ordinances. She said that in light of some neighbor concerns, she feels that explicitly spelling this out is a good idea. Director Garvy stated he shared Commissioner Altpeter's concerns and had communicated this to park district legal counsel. He reported that once he receives a revised document he will forward it to the board for their review.

X.STAFF REPORTS

A. Arboretum Woods Park Renovations- Update

President Cook stated the District and V3 have done a great job so far. Superintendent Cerutti stated they found quite a few different types of fish in the ponds such as bluegills, bass, bullheads, carp and even some coy. Director Garvy stated by the end of August, the shoreline work at both ponds along with outcropping stones should be complete. By September 11th the removal of the existing limestone path and instillation of the asphalt path should be complete. He will continue to keep the board and residents of the area posted.

B. Honey Bees-Update

Director Garvy reported the front desk at the Senior Center and Recreation Center is selling the honey that had been extracted from the hives in Community Park. He stated the 1lb jar is \$10 and the 8oz. jar is \$7 and that so far is has been very popular.

Commissioner Hough asked that copies of the museum's MAP Grant be provided to the board.

Commissioner Hough asked Superintendent Leone what the District 203 meeting was about. Superintendent Leone stated it was for a back to school event at the Naper Settlement that will take place on Saturday August 29th and the District will be hosting some games. Director Garvy thanked Superintendents Leone and Toohey for

coordinating this event, as well for their coordination and participation in the recent National Night Out that was hosted by Benedictine University.

XI.PARTNERS FOR PARKS REPORT

Superintendent Leone reported that Lisle Partners for Parks Foundation will be hosting the Chamber Business After Hours and Birdhouses Community Art Project Preview on August 26th from 5-7pm at the Recreation Center. Chef by Request will be catering. She reported that on December 1st the Foundation will have an event to showcase the scholarship program and the Wheatstack fundraiser raised \$480 for the foundation. She reported the Scarecrow Scramble & Fall Festival will be on October 17th.

XII.SEASPAR REPORT

Director Garvy reported that SEASPAR has hired a Marketing and PR person. He reported he and Director Friend had met with the new mayor of Indian Head Park for a SEASPAR orientation. He also reported the continued demand for inclusion aids by member agencies. He stressed the importance of program registrants' need to provide ample notice should they need an aid because SEASPAR has to secure them on an as-needed basis. He stated, "It's not like they call the union hall and ask to send someone over." He said that while they have a small pool of aids, the demand continues to far outweigh their supply.
